II. Information we collect and Use

Live to Love does not require personal information other than cookies from visitors to access the website.

Any donation made on our website is PCI compliant under "PCI validation: SAQ A". It utilizes Stripe Elements technology that has financial input fields that are done securely in Stripe's iframe. Stripe is certified as a PCI Level 1 Service Provider. This is the most stringent level of certification available in the payments industry.

You directly provide us with your personal information such as name, phone number and email address.

We seek such details to facilitate your donations or other engagements on our website and to communicate with you about our updates and activities.

B. We may collect anonymous data via cookies to improve your experience on our website. This helps us provide an enhanced online user experience. Please read our Cookie Statement for more information.

III. Security and Data Retention

We store your data electronically in secure servers to protect the confidentiality and integrity of your personal data.

We will retain your data for as long as required by applicable laws or in accordance with the purpose of collection and the appropriate consent provided by you. Once this time period has expired, we will delete your data.

IV. Third-Party Websites

If you land on third-party websites through our website, you are consenting to the terms and privacy policies of those third-party websites.

We may share your information with third parties who process data on our behalf to analyze visitor behavior. We impose security restrictions and monitor any access to your data while keeping your identity anonymous.
